0132220E. ALL FLIGHTS, INCLUDING THE OPERATION OF MODEL AIRCRAFT AND UNMANNED AIRCRAFT SYSTEMS, ARE PROHIBITED IN THE AREA EDR HUMBOLDT. THESE FLIGHT RESTRICTIONS DO NOT APPLY TO:

- MISSION FLIGHTS OF THE GERMAN ARMED FORCES, THE GERMAN FEDERAL POLICE AND THE POLICE FORCES OF THE GERMAN FEDERAL STATES (LAENDER),
- FLIGHTS ON BEHALF OR AT THE INITIATIVE OF THE POLICE,
- FLIGHTS APPROVED BY THE POLICE,
- FLIGHTS BY THE GERMAN ARMED FORCES RELATED TO THE STATE VISIT,
- RESCUE AND DISASTER RELIEF FLIGHTS,
- AMBULANCE FLIGHTS,
- FLIGHTS BY STATE AIRCRAFT RELATED TO THE STATE VISIT,
- FLIGHTS CONDUCTED ENTIRELY UNDER IFR (CHANGE PROCEDURES - Y AND Z FLIGHT PLANS - ARE NOT ALLOWED) WHICH FULFIL THE ICAO STANDARDS LAID DOWN IN ANNEX 17 (SAFEGUARDING INTERNATIONAL CIVIL AVIATION AGAINST ACTS OF UNLAWFUL INTERFERENCE) AS WELL AS REGULATION (EC) NO. 300/2008 OF THE EUROPEAN PARLIAMENT AND THE COUNCIL OF 11 MARCH 2008,
- FLIGHTS BY MODEL AIRCRAFT AND UNMANNED AIRCRAFT SYSTEMS AT A DISTANCE OF MORE THAN 10NM FROM 523134N 0132220E, TAKING ACCOUNT OF THE REGULATIONS OF SECTION 21(H) OF THE GERMAN AVIATION REGULATION (LUFTVO) AND UNLESS THEY DO NOT FLY ABOVE AN ALTITUDE OF 120M ABOVE GROUND.

PRIOR TO ENTERING, DEPARTING OR TRANSITING THE AIRSPACE, THESE AUTHORISED MANNED VFR FLIGHTS SHALL REPORT TO THE POLICE OF BERLIN AND WILL BE SUBJECT TO APPROVAL. THE PROCEDURES FOR OBTAINING THIS APPROVAL WILL BE COMMUNICATED BY THE POLICE VIA APPROPRIATE CHANNELS. TRAINING FLIGHTS, PHOTO AND CALIBRATION FLIGHTS (INCLUDING UNDER IFR) ARE NOT ALLOWED.

CONTINUOUS AIR-GROUND VOICE COMMUNICATION WATCH SHALL BE MAINTAINED ON FREQUENCY 135.600MHZ (CALLSIGN POLICE INFO) BY ALL AUTHORISED MANNED VFR FLIGHTS WHILE FLYING WITHIN EDR HUMBOLDT.

INFORMATION ON THE CURRENT STATUS OF EDR HUMBOLDT CAN BE REQUESTED ON FREQUENCY 132.650MHZ, LANGEN INFORMATION.

TRANSIT PERMISSIONS IN LINE WITH SECTION 17 OF THE GERMAN AVIATION REGULATION (LUFTVO) WILL NOT BE GRANTED.

NOTE: TRANSIT PERMISSIONS ISSUED FOR RESTRICTED AREAS EDR4, EDR54, EDR55, EDR56 OR EDR146 DO NOT INCLUDE A TRANSIT PERMISSION FOR THE RESTRICTED AREA EDR HUMBOLDT.
